FOR FURNISHING EQUIPMENT**

Sealed quotations will be received by the Board of County Road Commissioners of the County of Gratiot at their office at 200 Commerce Drive, PO Box 187, Ithaca, Michigan 48847 until **10:00 A.M., TUESDAY, FEBRUARY 13, 2018** for furnishing miscellaneous pieces of equipment to be used in conjunction with the Commission's Construction and Maintenance Work Program.

Bidders shall submit a listing of equipment and the hourly rental rate for same under their letterhead. Rental rate shall include total cost per hour for furnishing equipment including operator and fuel. Payment will be based on hours or productivity only and down time (repairs, etc.) will not be subject to payment. Prices shall remain firm through March 31, 2019.

Bidder should review Commission's construction program, including scheduled working hours, with the Superintendent.
