SCRAPER BLADES

1. **PRICE BY THE BLADE**
2. Complete manufacturer's specifications shall be included with each bid.
3. Holes on all blades shall be punched to allow use of 5/8" mounting bolts.
4. Blades are to be painted.
5. Blades to bolt on Root or Monroe Underbody moldboards.
6. FOB-Delivered to Gratiot County Road Commission Garage, 920 E. Center St., Ithaca, MI.
7. Blades to bolted in bundles of ten blades.
8. Minimum Shipping Time

Proposals should be in a sealed envelope marked SCRAPER BLADE BIDS.

The Board reserves the right to accept or reject any part of or all bids and/or quotations and to waive any informality in the bidding which in their opinion will be beneficial to the County of Gratiot.
